- 
- ▶ Tortuous process !
 - ▶ Current Wai 30 structure includes Moana representatives (4) plus two iwi -Ngāti Mahuta and Ngāti Te Wehi and Lead Negotiator
 - ▶ Engagement with Waikato- Tainui has been difficult at times
 - ▶ Currently considering a 3 partner agreement (Oati) with Maniapoto and Waikato Tainui, we recognise and respect each other. (WAI and MACA)

Mandate

- ▶ Ngāti Hikairo not formally part of Wai 30 and remaining claims
- ▶ Seek mandate from you
- ▶ Achieve Mandate by year end
- ▶ Can opt in up until signing of a deed of settlement
- ▶ Timeline for deed of settlement not yet determined
